FEES AND PAYMENT OPTIONS

FEES FOR 2026-2027

Application Fee (Non-refundable): **\$100 per child** due at time of application. This is a one-time fee.

Admin Fee (Non-refundable): **\$450 per student**. This is an annual fee for each student (K-12) which helps to defray the cost of materials and supplies. (*Returning students are billed a discounted Admin Fee of \$400 if paid by May 15, 2026.*)

Athletic Fee: \$110 per sport with a maximum of \$200 per family per sport. This is only for students who choose to participate in the sport program to defray the cost of transportation and professional referees.

Tuition (Full year for K-12th grade): **\$7,900**

Tuition Discounts:

Multiple child discount: 1st child - full tuition
2nd child - 10% discount
3rd child - 20% discount
4th child - 30% discount

Early payment discounts: See Payment Options

Financial Aid: You may apply for financial aid **after** your application has been received. Go to uptonlake.com and click on the FACTS logo (graduation cap) at the bottom of the page. Financial aid is awarded on a first-come, first-served basis for enrolled students. Those receiving financial aid will be asked to donate at least 20 hours of their time to Upton Lake.

PAYMENT OPTIONS

1. If *full payment* of tuition for your first student is made directly to ULCS by August 4, you will be entitled to a \$200/family tuition discount.
2. *Quarterly payments* can be made through FACTS. There is a \$50 processing fee payable to FACTS for this type of payment.
3. *Automatic monthly payments* can be made through FACTS. Payments are made over a 10 month period and are automatically made by your bank on either the 1st or the 20th of the month starting in August. There is an annual \$50 processing fee payable to FACTS for this payment option.
4. Pre-authorized credit card payments can be made through FACTS. Pre-authorized credit card payments (plus processing fee) or direct ACH from bank accounts (no fee) can be made through FACTS.
5. *Monthly Invoice Option*: FACTS will mail invoices 20 days prior to the due date selected (either the 1st or 20th of the month). If the payment is not received by 10 days after the due date, a late fee of \$25 will be assessed. Returned check fees are \$30 and will be invoiced. There is a \$50.00 processing fee payable to FACTS for this method of payment.

OTHER POLICIES

1. Non-payment of tuition: You must contact the school if you find that you have become unable to meet your financial commitments to the school. We are willing to make Christ-honoring accommodations if you contact us. If you fall two months behind in your payments and have not contacted us, your child will not be able to return to school until your account is current. All fees and tuition must be paid in full before a final report card, diploma, or transcript will be issued to a student, parent, or any other school. If a tuition balance remains, a student may not be able to start a new school year.
2. If a payment is missed or a check is returned for insufficient funds, you will be charged a \$30 missed payment fee.
3. We respect the sacrifice that Christian parents demonstrate in paying for Christian school. The cost of the full program is defrayed through the gifts of volunteers, financial contributions, and fund raising efforts. If you contribute your time and talents to ULCS it is greatly appreciated and useful in keeping tuition costs as reasonable as possible.

ULCS TUITION REIMBURSEMENT POLICY

A student who is enrolled at Upton Lake Christian School as of the first day of any month is considered enrolled for the entire month. As such, if his/her family withdraws a student on any day of an enrolled month, the school must retain full tuition for that month. Families who have prepaid beyond the enrolled month, in which a student has been withdrawn, will receive a refund of the amount paid for the remaining months minus any discounts or other outstanding balances as recorded on Upton Lake Christian School account records.
